## How it all started – The Americans with Disabilities Act

- The Americans with Disabilities Act was passed in 1990 as a comprehensive civil rights law that prohibits discrimination against individuals with disabilities within employment, public services, public accommodations, and telecommunications.
- The Americans with Disabilities Act created 5 titles.
  - Title I employment
  - Title II public entities
  - Title III public accommodations
  - Title IV telecommunications (IP CTS)
  - Title V miscellaneous provisions



## Internet Protocol Captioned Telephone Service

- (IP CTS)
  IP CTS is a form of Telecommunications Relay service. This service allows people with hearing loss to speak as they would normally speak on a phone call but gives them the ability to read captions when the caller responds.
- The operator generates captions of what the other party to the call says. These captions are then sent to your phone. The cost for the service is paid from a federally-administered fund.



## Is ClearCaptions Really Free For Customers?

Yes - ClearCaptions phone captioning service is completely free for qualified individuals whose hearing loss inhibits their phone use.

The Federal Communications Commission is committed to providing equal communications to people with recognized hearing-loss to fulfill the mandate of the Americans with Disabilities Act (ADA)



#### Funding of Products and Services

- All ClearCaptions IP CTS products and services are offered at no cost.
- IP CTS services are paid for out of a federal fund called the Telecommunications Relay Services Fund. As such, ClearCaptions is reimbursed directly from the TRS Fund for minutes of service provided to our customers.
- Every carrier providing interstate or intrastate telecommunications services (including interconnected VoIP service providers) and every provider of noninterconnected VoIP service contribute to the TRS Fund.



### How ClearCaptions Works

ClearCaptions is a free phone captioning service that provides near real-time call captions of phone conversations for individuals whose hearing loss inhibits their phone use.

Similar to captioned television, ClearCaptions allows for you to read realtime written call captions of what callers say on our revolutionary home phone, your mobile device, or your computer.

This free captioning service is provided by ClearCaptions and paid through a fund administered by the Federal Communications Commission (FCC). There is no cost to qualified individuals whose hearing loss inhibits their phone use.




