Motion Passed by the Executive Board in October

Starting with the January 2015 meeting, lunch will cost will increase from \$19 to \$20 per month. However, the board passed a resolution to allow members to prepay lunches for the entire 2015 year for \$190, a savings of \$10 over the month to month rate.

However, to take advantage of this offer, you must pay the treasurer by 1/5/2015. If you pay prior to this date, date your check as 1/5/2015, as they will be deposited on or after that date. Make your check payable to "SIR Branch #62".

Branch members who choose this option may also include their annual membership dues of \$10, for a total of \$200.
